Dear Mount Amanzi Member

SUBJECT: 2018 RESORT CALENDAR

We attach hereto the 2018 annual resort calendar for your attention and review.

We wish to bring to your attention the fact that the Department of Education in their wisdom decided to change the sequence or time periods of school holidays for 2018 (a similar anomaly occurred in 2014), which will have a direct impact on the allocation of the weeks/modules throughout the year. Whilst we understand that the departmental changes do affect us all, the Board is unfortunately duty bound in terms of the Use Agreement to follow the predetermined weeks/modules and allocations in accordance with the provisions of the Use Agreement and the only way to amend the Use Agreement would be if 100% of all the members agreed to the change.

We further confirm that the timeshare contract you signed donates timeshare weeks/modules, which have a sequence of allocation based on the school holiday calendar for each year. The Use Agreement contains the mandatory definitions of the various seasons and types of weeks/modules. The point of departure however, is the dates of the school holidays as reflected in the Use Agreement. The School Holidays and Public Holidays for 2018 are atypical and as a result the peak seasons (as determined by RCI on a Friday to Friday basis) dominates the definition followed by the shoulder weeks/modules and then the normal weeks/modules. All resulting in the week/module allocations as per the attached calendar.

We wish to point out that in 2018 the Department of Education has declared 2 weeks which run from a Wednesday (28 March 2018) to a Tuesday (10 April 2018) as school holidays, resulting in only 1 week being a full Friday to Friday peak week in the school holidays. The second peak week season (according to RCI) will only be 3 weeks later commencing on Friday, 27 April 2018, due to the fact that there are 2 public holidays and 1 school holiday in that week. This classifies it as a peak week season.

Unfortunately, as stipulated above, we are bound by the terms and conditions of the Use Agreement as well as the yearly government school holidays in terms of the compilation of the annual resort calendar and request your understanding in this regard as well as request you to please take note of your week/module dates for 2018 and make your holiday arrangements in accordance therewith.

Should you wish to utilize the week/module immediately following the first peak week/module you are welcome to contact us to see if we are able to accommodate an exchange, subject to availability of course.
